- Reduce the environmental effect of our procurement activities, promote social responsibility and ethical labor standards throughout our supply chain, and encourage long-term growth through partnering with a broad supplier base.
- We will give preference to products and services that have a lower environmental impact and meet recognized sustainability standards. This includes products with energy-efficient features, reduced packaging, and third-party.
- When procuring equipment, we will prioritize products that meet or exceed recognized energy efficiency standards.
- Drive the adoption of best global sustainable practices across the supply chain, by establishing partnerships with our suppliers, with the common goal to continuously improve performance over time.
- Strive to include sustainability practices, performance, and transparency as part of ICL's supplier selection process, encouraging active sustainability partners among our suppliers.
- We will regularly monitor and report on the progress of our sustainable procurement efforts, assessing the effectiveness of this policy and making necessary improvements.
- This Policy will be reviewed and, if necessary, revised regularly to ensure it remains aligned with ICL's sustainability goals and evolving best practices.

Speak-Up:

ICL will never retaliate against anyone who submitted a report or concern, in good faith, through any of our reporting channels.
